Empanelment of Audio-Video and FILM Producers

BIHAR STATE FILM DEVELOPMENT AND FINANCE CORPORATION LIMITED (BSDFCL) wishes to receive proposal from the experienced Film Producers & Production House to be empanelled as "Producers/Production Agencies"

Various Departments/Institutions under the Government of Bihar or Private agencies require the services of audio-video agencies/producers for publicity of their programmes and policies. With this end in view, BSDFCL will empanel audio-video producers to utilize their services for audio-video publicity of various government policies and programmes. The empanelled audio-video producers with BSDFCL will be used as a pool for carrying out such activities at the existing/approved rate of I&PRD (GoB)/DAVP, Govt of India with a deduction of 5% of billed amount as facilitation charges. If required, the rate card for production work will be notified by BSDFCL separately.

ELIGIBILITY CRITERIA:

(Necessary documents/material must be furnished along with the applications):

- a) The producers/production agencies should have a minimum Turnover of Rs.5.00 lakh for Last 3 FY (Balance Sheet of last 3 FY duly certified by CA along with PAN must be submitted).
- b) Registered organization with Service Tax should possess (Registration copy must be attached).
- c) Having produced programmes for Doordarshan or any Satellite Channel or any Govt/Private agency (Approval Letter/Telecast certificates along with programmes in CD must be submitted).
- d) Professional experience of having produced programmes for more than 2 productions (work order copies must be submitted).
- e) Demand draft of Rs.5,000/- (non-refundable) in favour of MD, BSDFCL as processing fee.


The producer will submit a certificate to the effect that the information submitted by him/her is correct. Anyone found guilty of furnishing false information shall be disqualified from the panel for a period of 3 years.

The empanelment does not guarantee that the work will be provided to the producers necessarily.

Producers seeking empanelment must submit their proposal latest by 2<sup>nd</sup> June 2016 till 4 PM to the office of Managing Director, BSDFCL, Morrison Bhawan, Patna.

The undersigned reserves the right to cancel any proposal without giving any reason.

In case of any dispute with regard to implementation of guidelines, the decision of MD, BSDFCL shall be final.
